So You're an International Arbitrator: How to Approach and Handle Some of the Issues that May Arise.

This session will cover a number of issues that international arbitrators may face during an international arbitration. The panel will discuss how to determine which jurisdiction's law should apply and how different laws (i.e., substantive laws, procedural laws, specialized laws) that may apply impact that determination as they interpret the arbitration agreement.
